Together, we’ve made great strides, and with your continued support, I know we can achieve even more. Let’s build on the momentum of this past year and make 2025 a year to remember.



# CRITERIA FOR RECIPIENTS



## **LOWPAC contributes only to congressional, state and local candidates, not presidential**

We contribute to congressional, state and local candidates (in certain states), as well as Political Action Committees (PACs) and Party Committees. We regularly evaluate our political giving. As we assess candidates and elected officials, we will continue to rely on our established criteria and the actions of those we consider supporting.

## **LOWPAC backs candidates who understand our issues**

LOWPAC primarily engages with federal and state candidates who are influential on the issues that matter to us. LOWPAC receipts and disbursements are publicly reported through the Federal Election Commission (FEC).


## **Associates' personal contributions fund 100% of LOWPAC**



# KEY ISSUES



## What does LOWPAC do?

To address issues important to Lowe's, LOWPAC

- **Cultivates stronger alliances** with legislators and state regulators, including State Attorneys General.
- **Increases presence** in federal and state policymaking processes.
- **Bolsters relationships** with retail and multi-industry trade associations, including state trade associations.
- **Promotes vital public policy issues for Lowe's** because government touches every part of our business. Policies that impact our company include those listed above and many more.

# A LOOK AHEAD: 2025

**WORKFORCE** – We remain committed to workforce policies that address skilled labor shortages and strengthen long-term talent pipelines. Expanding the skilled trades talent pipeline is crucial to support our customers in the construction industry as well as our business operations, and we are regularly educating policymakers about the efforts of Lowe's and the Lowe's Foundation to invest in the skilled trades talent pipeline.

**TAXES** – In Washington, DC, several provisions of the Tax Cuts and Jobs Act of 2017 (TCJA) are set to expire at the end of the year, which Congress will need to address to avert significant tax increases for individuals and businesses. This will be a priority focus for Congress in Washington, DC this year, and we will remain engaged to assess impact of various proposals on the company, our customers and the communities we serve.

**TRADE** – In 2025, tariffs and trade actions will be a significant focus of the Trump Administration in Washington, DC. We will have to navigate proposals, new and expanded tariffs and ongoing trade negotiations that could result in increased costs for products. In collaboration with retail industry colleagues, we will educate policymakers about the potential adverse impacts of broad-based tariff actions on consumer and household goods.

**SUSTAINABILITY** – Sustainability remains a priority as new policies, such as Extended Producer Responsibility (EPR) for packaging and modernized bottle bills, are considered in many states to reduce waste and promote recycling. We will also continue to engage with the U.S. Department of Energy and state energy offices to support home energy efficiency programs under the Inflation Reduction Act (IRA), providing customers with rebates for eligible products and projects.

**COMMUNITY + STORE SAFETY** – Organized retail crime (ORC) remains a critical concern as large-scale theft and fraud disrupt communities and threaten public safety. Through our engagement with elected officials, we will continue to advocate for the utilization of advanced security technologies, enhanced fraud detection tools, and collaboration with law enforcement to combat ORC effectively. Safeguarding our associates, customers, and communities remains a top priority in fostering trust and security within our stores. In 2025, the government affairs team will expand their efforts to include advocating for regulatory measures aimed at preventing gift card fraud.

**EXTERNAL POLICY ORGANIZATIONS + GROUPS** – Engaging with external policy organizations, including federal and state retail associations will ensure that we stay informed on public policy developments that may impact our company and our industry, allowing us to adapt proactively. Strong relationships with these organizations can create opportunities for collaboration, advocacy, and influence. Additionally, these partnerships can provide avenues to enhance credibility and provide a collective voice on key issues, strengthening our ability to navigate public policy challenges and drive meaningful change.

**ARTIFICIAL INTELLIGENCE** – Artificial intelligence (AI) is transforming our business by enhancing personalization, optimizing operations, and improving customer experiences. However, its rapid adoption has raised concerns regarding privacy, security, ethics, and economic impact, prompting various public policy proposals at the state and federal levels. As these discussions continue to evolve, it is essential that we actively engage to provide insights on consumer benefits of this emerging technology.
